# What is e-learning box

The **GDPR e-learning Box** is a complete distance educational program for your employees. The goal of the program is to raise awareness and to train your employees in order for the latter to meet GDPR requirements and contribute to the company's compliance.

## Training is an obligation

The obligation for appropriate and continuous training on data protection of employees who have access in personal data and participate in processing activities arises from the GDPR provisions:

- **Article 5 of the Regulation**  
The principle of accountability: The data controller is responsible to demonstrate compliance with all principles governing personal data processing; lawfulness, fairness, transparency, data minimization, data accuracy, integrity and confidentiality.
- **Article 39 of the Regulation**  
The duties of the Data Protection Officer with respect to the training of the employees involved in the data processing.
- **Articles 15-22 of the Regulation**  
The ability of the employees to handle data subjects' requests that may be submitted.
- **Article 25 of the Regulation**  
The minimization of the risk of a data breach, within the framework of personal data protection by design and by default.
- **Article 30 of the Regulation**  
The appropriate keeping of Record of processing activities

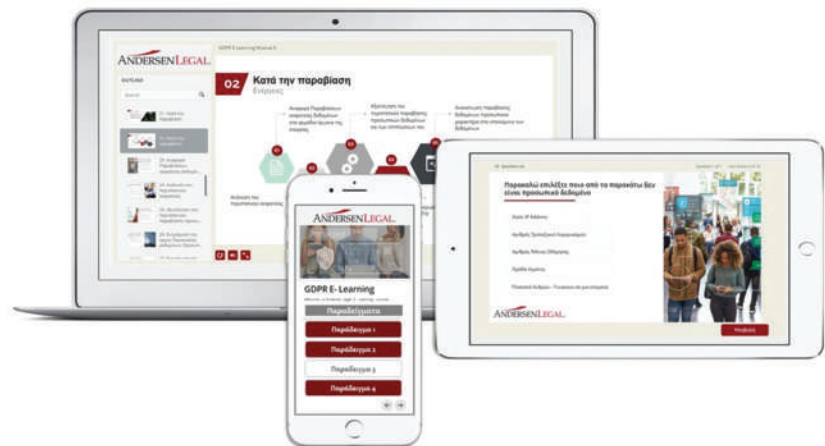
